- Fish & seafood market includes retail sale of ambient fish & seafood, chilled raw packaged fish & seafood - processed, chilled raw packaged fish & seafood - whole cuts, frozen fish & seafood, fresh fish & seafood (counter), and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Spanish fish & seafood market recorded revenues of \$15,718.4 million in 2024, representing a compound annual growth rate (CAGR) of 2.3% between 2019-24.
- Market production volumes declined with a negative CAGR of 0.4% between 2019-24, reaching a total of 931.4 million kilograms in 2024.
- Spanish fish & seafood market growth during the review period was driven by the expanding economy and rising household incomes, supporting increased consumer demand for healthier seafood options. According to Eurostat, in 2024, the net disposable income per household in Spain reached \$47,567.1, up 6.6% from 2019.
