The top 5 emerging countries are expected to reach a value of \$4,78,227.0 million in 2029, with a CAGR of 3.1% over the 2024-29 period.
- Within the apparel retail industry, China is the leading country among the top 5 emerging nations, with market revenues of \$2,86,803.6 million in 2024. This was followed by India and Brazil with a value of \$68,008.3 and \$24,600.9 million, respectively.
- China is expected to lead the apparel retail industry in the top five emerging nations, with a value of \$3,29,226.4 million in 2029, followed by India and Brazil with expected values of \$81,800.0 and \$29,727.7 million, respectively.
