- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The apparel retail industry within the NAFTA countries had a total market value of \$4,83,720.0 million in 2024. The Mexico was the fastest growing country, with a CAGR of 19.2% over the 2020-24 period.
- Within the apparel retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$4,38,165.2 million in 2024. This was followed by Canada and Mexico, with a value of \$23,609.0 and \$21,945.8 million, respectively.
- The US is expected to lead the apparel retail industry in the NAFTA bloc, with a value of \$4,96,883.3 million in 2029, followed by Canada and Mexico with expected values of \$28,822.1 and \$24,316.2 million, respectively.
