The syrups & spreads industry within the NAFTA countries had a total market value of \$10,090.3 million in 2024. The Mexico was the fastest growing country, with a CAGR of 6% over the 2020-24 period.
- Within the syrups & spreads industry, the US is the leading country among the NAFTA bloc, with market revenues of \$7,971.5 million in 2024. This was followed by Mexico and Canada, with a value of \$1,266.5 and \$852.3 million, respectively.
- The US is expected to lead the syrups & spreads industry in the NAFTA bloc, with a value of \$9,423.8 million in 2029, followed by Mexico and Canada with expected values of \$1,587.8 and \$1,024.2 million, respectively.
