- In 2024, the Argentinian consumer electronics retail market experienced an annual contraction of 14.0% due to the increased consumer price inflation. According to the National Institute of Statistics and Censuses (INDEC), in 2024, the consumer price inflation in Argentina reached 236.8%, up 85.1% annually.
