- The household appliances segment accounted for the market's largest proportion in 2024, with total revenues of \$11.3 billion, equivalent to 33.2% of the market's overall value.
- The market contraction during 2019-24 is attributed to a marked downturn from 2022-24 due to high inflation and rising living costs. According to the National Institute of Statistics and Economic Studies, in 2022 and 2023, the consumer price inflation in France reached 5.2% and 4.9%, respectively, up from 1.1% in 2019.
