- The communications equipment segment accounted for the market's largest proportion in 2024, with total revenues of \$4.1 billion, equivalent to 42.4% of the market's overall value.
- The growth of the Filipino consumer electronics retail market is driven by the rise in household income, which has significantly enhanced consumer purchasing power and broadened the middle-class base. According to the Philippine Statistics Authority (PSA), in 2024, the gross national disposable income in the Philippines reached PHP31.7 trillion (\$553.4 billion), up 10.5% annually. This rise in income accelerated the demand for high-end household appliances and consumer electronics.
