- The growth of the Portuguese consumer electronics retail market is driven by the rise in net disposable income per household, which has significantly enhanced consumer purchasing power and broadened the middle-class base. According to Eurostat, in 2024, the net disposable income per household in Portugal reached \$43,190.6, up 4.3% annually.
