- The communications equipment segment accounted for the market's largest proportion in 2024, with total revenues of \$6.5 billion, equivalent to 28.9% of the market's overall value.
- In 2024, the Spanish consumer electronics retail market experienced an annual growth rate of 5.1%, driven by the rise in households owning personal computers. According to the Organization for Economic Co-operation and Development (OECD), in 2024, the proportion of households with personal computers in Spain reached 85.8%, up from 84.0% in 2023. This rise in personal computer penetration is driven by a growing need for digital connectivity to support remote work, online education, and entertainment.
