- The Taiwanese consumer electronics retail market recorded revenues of \$14.2 billion in 2024, representing a compound annual growth rate (CAGR) of 2.1% between 2019 and 2024.
- The communications equipment segment accounted for the market's largest proportion in 2024, with total revenues of \$7.4 billion, equivalent to 52.0% of the market's overall value.
- The growth of the Taiwanese consumer electronics retail market is driven by the rise in household income, which has accelerated the demand for high-end household appliances and consumer electronics. According to the Directorate-General of Budget, Accounting and Statistics (DGBAS), in 2024, the average annual income for individuals under 30 in Taiwan increased to TWD559,000 (\$18,606), up 2.5% annually.
