- The Dutch consumer electronics retail market recorded revenues of \$14.8 billion in 2024, representing a compound annual growth rate (CAGR) of 4.8% between 2019 and 2024.
- The computer hardware & software segment accounted for the market's largest proportion in 2024, with total revenues of \$4.7 billion, equivalent to 31.8% of the market's overall value.
- In 2024, the Dutch consumer electronics retail market recorded an annual growth of 2.2% due to a decline in consumer price inflation. According to Statistics Netherlands, in 2024, the consumer price inflation in the Netherlands reached 3.3%, down from 3.8% in 2023. Easing inflationary pressures helped stabilize household purchasing power, enabling consumers to spend more on discretionary categories such as smartphones, laptops, and household appliances.
