- The Turkish consumer electronics retail market recorded revenues of \$28.4 billion in 2024, representing a compound annual growth rate (CAGR) of 16.4% between 2019 and 2024.
- The communications equipment segment accounted for the market's largest proportion in 2024, with total revenues of \$13.3 billion, equivalent to 46.8% of the market's overall value.
- In 2024, the Turkish consumer electronics retail market experienced an annual growth rate of 25.0%, driven by the rise in households owning personal computers. According to the Organization for Economic Co-operation and Development (OECD), in 2024, the proportion of households with personal computers in Turkey reached 49.5%, up from 48.4% in 2023. This rise in personal computer penetration is driven by a growing need for digital connectivity to support remote work, online education, and entertainment.
