- The communications equipment segment accounted for the market's largest proportion in 2024, with total revenues of \$5.8 billion, equivalent to 50.6% of the market's overall value.
- In 2024, the Vietnamese consumer electronics retail market recorded an annual growth of 0.3% due to accelerated urbanization. According to the World Bank, in 2024, the urban population in Vietnam reached 40.6 million, up 2.6% annually. This rise in urban population reshaped consumer lifestyles, driving demand for modern household appliances such as refrigerators and microwave ovens.
