- The games software retail market includes games for domestic game consoles, handheld game consoles, mobile phones, and other wireless devices, and games for PC and Mac desktop computers. Online games are excluded (e.g., Second Life) from our scope. Market value includes retail sales.
- The Canadian games software retail market recorded revenues of \$1,533.1 million in 2024, representing a compound annual growth rate (CAGR) of 0.5% between 2019 and 2024.
- Online specialists account for the largest proportion of sales in the Canadian games software retail market in 2024, sales through this channel generated \$645.0 million, equivalent to 42.1% of the market's overall value.
- The sluggish growth of the Canadian games software retail market during 2019-24 can be attributed to inflation and repeated currency devaluations, which eroded consumer purchasing power, making it more difficult for people to commit to higher-priced software.
