- Online specialists account for the largest proportion of sales in the French games software retail market in 2024; sales through this channel generated \$1,063.8 million, equivalent to 28.0% of the market's overall value.
- The sluggish growth of the French games software retail market during 2019-24 can be attributed to the increasing shift towards digital gaming platforms, which has led to a decline in physical game sales, which traditionally constituted a significant portion of the retail market.
