- The games software retail market includes games for domestic game consoles, handheld game consoles, mobile phones, and other wireless devices, and games for PC and Mac desktop computers. Online games are excluded (e.g., Second Life) from our scope. Market value includes retail sales.
- The Japanese games software retail market recorded revenues of \$2,844.7 million in 2024, representing a negative compound annual growth rate (CAGR) of 1.4% between 2019 and 2024.
- Online specialists account for the largest proportion of sales in the Japanese games software retail market in 2024; sales through this channel generated \$979.1 million, equivalent to 34.4% of the market's overall value.
- Japan captured a share of 15.8% in the Asia-Pacific games software retail market in 2024. The market witnessed a contraction during 2019-24, due to the unstable economic conditions.
