- The accessories segment accounted for the market's largest proportion in 2024, with total revenues of \$8 billion, equivalent to 63% of the market's overall value.
- In 2024, South Korea accounted for a 3.7% share of the Asia-Pacific jewelry, watches, and accessories retail market.
