- Market consumption volume increased with a CAGR of 8.2% between 2019 and 2024, reaching a total of 4,202,498.0 units in 2024.
- In 2024, the Indian new cars market grew by 4.7% annually, fueled by increased per capita disposable income. According to the Reserve Bank of India, the net disposable income per household in India increased to \$7,984.2 in 2024, from \$7,631.8 in 2023. This rise in income has positively influenced consumer purchasing power and the demand for new cars.
