- The Indonesian new cars market recorded revenues of \$9.9 billion in 2024, representing a compound annual growth rate (CAGR) of 0.7% between 2019 and 2024.
- Market consumption volumes declined with a negative CAGR of 3.2% between 2019 and 2024, reaching a total of 649,925.0 units in 2024.
- In 2024, the volume of the Indonesian new cars market experienced a decline of 3.2% annually, primarily driven by rising interest rates. According to the Bank of Indonesia, the interest rates in Indonesia increased to 6.3% in April 2024. The rise in interest rates typically wanes consumer confidence, leading to a decreased willingness to make significant purchases such as vehicles.
