- The Kazakhstani new cars market recorded revenues of \$5.8 billion in 2024, representing a compound annual growth rate (CAGR) of 23.3% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 23.7% between 2019 and 2024, reaching a total of 190,913.0 units in 2024.
- In 2024, the volume of the Kazakh new cars market grew by 3.4% annually, fueled by increased real GDP growth. According to the World Bank, in 2024, the real GDP growth in Kazakhstan grew by 3.8% annually. This economic development has positively influenced consumer purchasing power and the demand for new cars. Additionally, the rise in the urban population rate supported the market growth.
