- Market consumption volume increased with a CAGR of 2.5% between 2019 and 2024, reaching a total of 1,238,129.0 units in 2024.
- In 2024, the volume of the Mexican new cars market grew by 13.6% annually, fueled by net disposable income per household. According to Eurostat, in 2024, the net disposable income per household in Mexico grew by \$34,089.3 from \$31,708.3 in 2023, reflecting a 5.3% nominal increase annually.
