Summary

- New cars market includes retail sales/registrations of new passenger cars. The scope of passenger cars covers saloons, hatchbacks, SUVs, 4x4s, and light pickup vehicles. Market volume refers to the total number of cars sold in a year, while market value is calculated by multiplying the average retail selling price with the market volume.
- The Taiwanese new cars market recorded revenues of \$11.4 billion in 2024, representing a compound annual growth rate (CAGR) of 1.9% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 0.04% between 2019 and 2024, reaching a total of 378,916.0 units in 2024.
- In 2024, the volume of the Taiwanese new cars market experienced a decline of 5.9% annually, primarily driven by rising consumer price inflation. According to the Asian Development Bank, the consumer price inflation rate increased to 2.2% in 2024. The rise in the inflation rate typically affects consumer confidence, leading to a decreased willingness to make significant purchases such as vehicles.
