- The bread & grains segment accounted for the market's largest proportion in 2024, with total revenues of \$2,363.8 million, equivalent to 42.7% of the market's overall value.
- The strong growth of the Canadian organic food market during 2019-24 is driven by increasing consumer disposable income and significant consumer spending on premium and higher-quality grocery products, and demand for chemical-free food.
