- Within the it services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,94,929.2 million in 2024. This was followed by India and Brazil with a value of \$66,700.6 and \$35,173.7 million, respectively.
- China is expected to lead the it services industry in the top five emerging nations, with a value of \$3,96,907.4 million in 2029, followed by India and Brazil with expected values of \$1,72,158.4 and \$92,387.0 million, respectively.
