The software industry within the NAFTA countries had a total market value of \$4,00,874.8 million in 2024. The Mexico was the fastest growing country, with a CAGR of 11.3% over the 2020-24 period.
- Within the software industry, the US is the leading country among the NAFTA bloc, with market revenues of \$3,59,354.7 million in 2024. This was followed by Canada and Mexico, with a value of \$28,364.6 and \$13,155.5 million, respectively.
- The US is expected to lead the software industry in the NAFTA bloc, with a value of \$5,98,713.0 million in 2029, followed by Canada and Mexico with expected values of \$52,619.1 and \$25,466.1 million, respectively.
