- Within the software industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,33,795.7 million in 2024. This was followed by India and Brazil with a value of \$38,072.9 and \$21,153.6 million, respectively.
- China is expected to lead the software industry in the top five emerging nations, with a value of \$2,80,931.0 million in 2029, followed by India and Brazil with expected values of \$1,02,007.7 and \$54,910.1 million, respectively.
