The savory snacks industry within the NAFTA countries had a total market value of \$69,891.4 million in 2024. The Mexico was the fastest growing country, with a CAGR of 8.4% over the 2020-24 period.
- Within the savory snacks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$59,912.9 million in 2024. This was followed by Mexico and Canada, with a value of \$5,643.2 and \$4,335.3 million, respectively.
- The US is expected to lead the savory snacks industry in the NAFTA bloc, with a value of \$66,930.8 million in 2029, followed by Mexico and Canada with expected values of \$7,326.7 and \$5,202.8 million, respectively.
