- Within the airlines industry, China is the leading country among the BRIC nations with market revenues of \$1,22,538.5 million in 2024. This was followed by Russia, India and Brazil with a value of \$25,511.0, \$17,636.6, and \$10,516.8 million, respectively.
- China is expected to lead the airlines industry in the BRIC nations with a value of \$1,68,292.9 million in 2029, followed by Russia, India, Brazil with expected values of \$42,157.5, \$26,851.0 and \$16,557.2 million, respectively.
