- Among the G8 nations, the US is the leading country in the bpo services industry, with market revenues of \$1,21,378.9 million in 2024. This was followed by Japan and the UK, with a value of \$20,588.8 and \$15,734.1 million, respectively.
- The US is expected to lead the bpo services industry in the G8 nations with a value of \$1,60,326.1 million in 2016, followed by Japan and the UK with expected values of \$25,138.7 and \$20,995.6 million, respectively.
