- Carbonated soft drinks market includes retail sales of carbonated drinks. However, the total market volume for carbonated soft drinks market excludes powder concentrates, which are included in the market value. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- By distribution channel, the market is segmented into convenience stores, foodservice, supermarkets, vending machines, and others. The scope of others includes direct sellers, food & drinks specialists, hypermarkets, e-commerce, etc.
- All market data and forecasts are based on nominal prices and all currency conversions used in the creation of this report have been calculated using yearly annual average exchange rates. The USD values may show a declining trend for few countries such as Argentina, Turkey, Nigeria, Egypt, and Russia. This is primarily because of the impact of exchange rates considered.
- The global carbonated soft drinks market recorded revenues of \$373,449.8 million in 2024, representing a compound annual growth rate (CAGR) of 4.9% between 2019-24.
- Market consumption volume increased with a CAGR of 1.9% between 2019-24, reaching a total of 221,497.9 million liters in 2024.
- The global carbonated soft drinks market registered healthy growth during 2019-24, primarily driven by the post-pandemic rebound in foodservice and on-the-go consumption, alongside strong value growth driven by price increases amid inflation and supply-chain cost pressures.
