- Within the carbonated soft drinks industry, Mexico is the leading country among the top 5 emerging nations, with market revenues of \$28,361.7 million in 2024. This was followed by China and Brazil with a value of \$24,980.6 and \$24,765.8 million, respectively.
- India is expected to lead the carbonated soft drinks industry in the top five emerging nations, with a value of \$46,841.1 million in 2029, followed by Mexico and Brazil with expected values of \$39,765.3 and \$32,944.5 million, respectively.
