Summary

Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the number of seats sold.
- The European airlines industry recorded revenues of \$342.7 billion in 2024, representing a compound annual growth rate (CAGR) of 1.4% between 2019 and 2024.
- Industry consumption volume increased with a CAGR of 0.4% between 2019 and 2024, reaching a total of 2,023 million seats in 2024.
- The UK accounted for a share of 17.4% of the European airlines industry in 2024.
