Summary

Industry volume is defined as the total number of seats sold by airlines registered in a particular country or region. Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the number of seats sold.
- The Italian airlines industry recorded revenues of \$27.3 billion in 2024, representing a compound annual growth rate (CAGR) of 4.1% between 2019 and 2024.
- Industry consumption volume increased with a CAGR of 2.6% between 2019 and 2024, reaching a total of 182 million seats in 2024.
- Italy accounted for a share of 8.0% of the European airlines industry in 2024.
