- The Mexican airlines industry recorded revenues of \$15.9 billion in 2024, representing a compound annual growth rate (CAGR) of 5.8% between 2019 and 2024.
- Industry consumption volume increased with a CAGR of 3.2% between 2019 and 2024, reaching a total of 119 seats in 2024.
- Mexico accounted for a share of 3.3% of the North American airlines industry in 2024.
