Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the number of seats sold.
- The Scandinavian airlines industry recorded revenues of \$14.0 billion in 2024, representing a negative compound annual growth rate (CAGR) of 0.4% between 2019 and 2024.
- Industry consumption volumes declined with a negative CAGR of 1.8% between 2019 and 2024, reaching a total of 103 million seats in 2024.
- Denmark accounted for a share of 39.1% of the Scandinavian airlines industry in 2024.
