Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the number of seats sold.
- The Dutch airlines industry recorded revenues of \$17.2 billion in 2024, representing a compound annual growth rate (CAGR) of 0.7% between 2019 and 2024.
- Industry consumption volumes declined with a negative CAGR of 1.2% between 2019 and 2024, reaching a total of 76.2 million seats in 2024.
- The Netherlands accounted for a share of 5.0% of the European airlines industry in 2024.
