Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the number of seats sold.
- The Turkish airlines industry recorded revenues of \$28.2 billion in 2024, representing a compound annual growth rate (CAGR) of 3.0% between 2019 and 2024.
- Industry consumption volume increased with a CAGR of 2.0% between 2019 and 2024, reaching a total of 230 million seats in 2024.
- Turkey accounted for a share of 8.2% of the European airlines industry in 2024.
