- The Chinese BPO services market recorded revenues of \$37.4 billion in 2024, representing a compound annual growth rate (CAGR) of 6.6% between 2019 and 2024.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2024, with total revenues of \$10.5 billion, equivalent to 28.2% of the market's overall value.
- In 2024, China accounted for a share of 34.1% of the Asia-Pacific BPO services market.
