The total value of the market represents the demand for the service coming from a particular country.
- The French BPO services market recorded revenues of \$9.3 billion in 2024, representing a compound annual growth rate (CAGR) of 5.4% between 2019 and 2024.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2024, with total revenues of \$2.8 billion, equivalent to 29.8% of the market's overall value.
- In 2024, France accounted for a share of 12.4% of the European BPO services market.
