The total value of the market represents the demand for the service coming from a particular country.
- The German BPO services market recorded revenues of \$12.3 billion in 2024, representing a compound annual growth rate (CAGR) of 5.5% between 2019 and 2024.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2024, with total revenues of \$3.4 billion, equivalent to 27.4% of the market's overall value.
- In 2024, Germany accounted for a share of 16.3% of the European BPO services market.
