The services include the outsourcing of functions such as customer relationship management, finance & accounting, human resources, knowledge process outsourcing, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Russian BPO services market recorded revenues of \$2.3 billion in 2024, representing a compound annual growth rate (CAGR) of 5.3% between 2019 and 2024.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2024, with total revenues of \$0.6 billion, equivalent to 27.8% of the market's overall value.
- In 2024, Russia accounted for a share of 3.0% of the European BPO services market.
