- Business Process Outsourcing (BPO) services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, finance & accounting, human resources, knowledge process outsourcing, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Scandinavian BPO services market recorded revenues of \$4.4 billion in 2024, representing a compound annual growth rate (CAGR) of 5.2% between 2019 and 2024.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2024, with total revenues of \$1.1 billion, equivalent to 24.6% of the market's overall value.
- In 2024, Sweden accounted for a share of 45.9% in the Scandinavian BPO services market, marking it the largest market in the region. It was followed by Norway with a 28.3% share and Denmark with a 25.8% share.
