The total value of the market represents the demand for the service coming from a particular country.
- The South African BPO services market recorded revenues of \$2.2 billion in 2024, representing a compound annual growth rate (CAGR) of 4.2% between 2019 and 2024.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2024, with total revenues of \$0.6 billion, equivalent to 28.2% of the market's overall value.
- In 2024, South Africa accounted for a share of 21.3% of the Middle East & African BPO services market.
