- Car rental refers to the short-term hiring of a motor vehicle from one party to another, typically excluding taxis. Our market scope includes only self-driven, short-term (i.e., less than 1 year) car rental data. It excludes leasing or rental of cars for more than one year and the chauffeur-driven cars/cabs.
- The French car rental market recorded revenues of \$2,977.6 million in 2024, representing a compound annual growth rate (CAGR) of 1.8% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 1.1% between 2019 and 2024, reaching a total of 241,998.0 Absolute units in 2024.
- In 2024, the volume of the French car rental market contracted by 0.2% annually. The contraction of the market is attributed to the rise in new car ownership, which has diminished the need for short-term rental services among both consumers and corporate clients. According to GlobalData, in 2024, the sales of new cars in France recorded an annual growth of 2.6%.
