- The Australian carbonated soft drinks market recorded revenues of \$5,526.7 million in 2024, representing a compound annual growth rate (CAGR) of 4.8% between 2019-24.
- Market consumption volume increased with a CAGR of 1.1% between 2019-24, reaching a total of 2,194.3 million liters in 2024.
- The Australian carbonated soft drinks market registered healthy growth during 2019-24, primarily driven by the pandemic recovery, as the full reopening of schools, workplaces, restaurants, and bars after the lifting of COVID-19 restrictions has led to a strong recovery in on-premise sales.
