- The carbonated soft drinks market includes retail sales of carbonated drinks. However, the total market volume for the carbonated soft drinks market excludes powder concentrates, which are included in the market value. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Canadian carbonated soft drinks market recorded revenues of \$4,078.1 million in 2024, representing a compound annual growth rate (CAGR) of 1.5% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 0.8% between 2019-24, reaching a total of 2,562.7 million liters in 2024.
- The Canadian carbonated soft drinks market registered sluggish growth during 2019-24, primarily due to Canada's slow economic growth during the review period, impacted by the Russia-Ukraine conflict and global COVID-19 lockdowns, which disrupted international trade and drove up inflation.
