- Market consumption volume increased with a CAGR of 0.5% between 2019-24, reaching a total of 45,863.0 million liters in 2024.
- The European carbonated soft drinks market registered healthy growth during 2019-24, primarily driven by the large population, rising disposable incomes, higher purchasing power, an increasing number of food processing facilities, warm weather, and substantial consumption from an expanding populace.
