- The French carbonated soft drinks market recorded revenues of \$5,819.6 million in 2024, representing a compound annual growth rate (CAGR) of 2.7% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 1.6% between 2019-24, reaching a total of 2,447.6 million liters in 2024.
- The French carbonated soft drinks market registered moderate growth during 2019-24, primarily driven by the advent of digital lifestyles, accelerated by the COVID-19 pandemic, which has driven more consumers toward online shopping.
