- Market consumption volumes declined with a negative CAGR of 1.3% between 2019-24, reaching a total of 7,884.4 million liters in 2024.
- The German carbonated soft drinks market registered strong growth during 2019-24, primarily driven by the large population, rising disposable incomes, higher purchasing power, an increasing number of food processing facilities, warm weather, and substantial consumption from an expanding populace.
