- The North American carbonated soft drinks market recorded revenues of \$122,216.7 million in 2024, representing a compound annual growth rate (CAGR) of 4.5% between 2019-24.
- Market consumption volume increased with a CAGR of 0.6% between 2019-24, reaching a total of 65,792.2 million liters in 2024.
- The North American carbonated soft drinks market registered healthy growth during 2019-24, primarily driven by the post-pandemic rebound in foodservice and on-the-go consumption, alongside strong value growth driven by price increases amid inflation and supply-chain cost pressures.
